This self-contained module optically scans the fingerprint when the user touches the glass imaging window. The U.are.U 5200 Module can be used with any standards-compatible fingerprint templates extractor or matcher, including the DigitalPersona<sup>®</sup> FingerJet<sup>™</sup> Biometric Engine.


